Notes from the Study Author

Simply put, we have a lot of data on K-12 education foundations, mostly on the nation's top 50 performers -- which we will begin calling the 'Industry's Top-50' as we continue to release our ongoing research.

I want to thank the nation's top K-12 foundation executives for completing surveys and phone interviews with me over the past four years. The surveys often take 20-30 minutes to complete; and the phone interviews rarely stop at 60 minutes. We really like data on K-12 education foundations and we are sorta nerds about it.

I hope local education foundations are able to use this study and data to make the case to grow their efforts that often add so much to the public education experience.

Next year will be the fifth consecutive year of Stepping Up's annual study of K-12 education foundations. An extended version of the study will include what we have learned in these five years.

Stepping Up is the nation's only annual study that ranks K-12 education foundations.

Introduction

Stepping Up is the nation's only annual study and ranking of K-12 education foundations. The study ranks the top 50 education foundations in the nation, and the top 10 in each of four divisions that allow for foundation comparisons of similar size.

This year's study includes 191 K-12 education foundations from 219 school districts, which represent the education foundations in the top 200 largest school districts (by student population), as well as top-performing foundations in smaller school districts.

"Our goal is to provide a non-biased national study of all top foundations regardless of the size of the district they support," said Dewey Caruthers, author of the study and president + ceo of caruthers institute, which conducts ongoing research of K-12 education foundations.

Achieve Minneapolis and Chattanooga Hamilton County Public Education Fund have both ranked in the top five three years in a row.

Top 5 Analysis

Dominating the top five for four consecutive years, Pinellas Education Foundation (Florida) has ranked first every year since the inception of this study.

Two foundations rank in the top five three years in a row. Achieve Minneapolis (Minnesota) has ranked in the top five three years in a row and is fourth this year (third and fifth in 2016 and 2015). Chattanooga Hamilton County Public Education Fund (Tennessee) ranked fifth this year and has ranked fifth and second in 2016 and 2015.

New to the study this year, Irvine Public Schools Foundation (California) ranks third.

Alliance for Education (Seattle, Washington) who made their first appearance in 2016's study has ranked second this year and fourth in 2016.

Pinellas Education Foundation Ranks first four years in a row.

Top 10 Analysis

Omaha Schools Foundation (Nebraska) ranks in the top ten four years in a row, ranking eighth this year.

Ranking in the top ten three years in a row, Denver Public Schools Foundations (Colorado) places 10th in 2017 and ninth and 10th in 2016 and 2015.

Boise Public Schools Foundation (Idaho) again ranks sixth for both 2017 and 2016.

Two foundations move into the top ten in 2017. Foundation for Lincoln Public Schools (Nebraska) ranks seventh, up from 13th in 2016. DC Public Education Fund (DC) moved up two spots to ninth.

Barbers Hill Education Foundation (Texas) jumped into the top ten this year. They previously ranked in Division 3 and 26th nationally. This year they rank 10th and are in Division 1. One reason for this, Barbers Hill increased their revenue from \$996,000 to \$7 million.



Five education foundations rank in the top 25 four years in a row.

- Hillsborough Education Foundation (Florida) 14th, 21st, 6th, 6th
- Clark Co. Public Education Foundation (Nevada) 13th, 17th, 14th, 2nd
- Foundation for Seminole County Public Schools (Florida) 12th, 14th, 16th, 10th
- The Fund for Public Schools (New York City) 24th, 16th, 10th, 7th
- The Boston Educational Development Foundation (Massachusetts) 25th, 18th, 23rd, 11th

New to the top 25, Polk Education Foundation (Florida) jumps from the top 50 to the top 25 ranking 21^{st} .



In the nation's top 25, only 4 foundations serve school districts with more than 100,000 students.

Two foundations have ranked in the top 25 for three consecutive years: (2017, 2016, 2015 respectively)

- Albuquerque Public Schools Foundation (New Mexico) ranked 18th, 15th, 7th
- DC Public Education Fund (DC) ranked 9th, 11th, 9th

10 foundations ranked in the top 50 for 4 years in a row.

Top 50 Analysis

This year's top 50 includes something new: a foundation from Division 4 (\$500,000 or less). Morris Educational Foundation (New Jersey) ranks 36th up from 51st last year. What Morris appears to lack in revenues, they make up for it in per student funds.

There are 10 foundations that ranked in the top 50 for four consecutive years (2017, 2016, 2015, 2014):



In it's first year of being included in Stepping Up, Barbers Hill Education Foundation (serving a school district of 4,000 students) ranked 26th. This year Barbers Hill not only increased their revenues enough to make a leap from Division 3 to Division 1, but they also made a leap in the rankings, up to 10th.

Division Analysis

Texas has the most top 10 Division appearances with 12 foundations in three divisions, although the state had only one in Division 1 – Barbers Hill Education Foundation.

Indiana has 6 foundations in Divisions 3 and 4 for the second year in a row.

Florida has 4 foundations in Divisions 1, 2, and 3 but none in Division 4.

Utah has 3 foundations in Division 2.

States with two foundations ranking in any Division top 10: California and Nebraska.

States with one foundation ranking in the top 10 in any of the four divisions: Minnesota, Washington, Tennessee, Idaho, Missouri, Colorado, Kansas, Louisiana, Oregon, New Jersey, North Carolina.



Northside Education Foundation (Texas) has ranked in the top 10 in Division 2 for four consecutive years (2017, 2016, 2015, 2014); and Spring Branch Education Foundation (Texas) for three years (2017, 2016, 2015).

Study Methodology

Stepping Up uses eight performance categories to rank the foundations nationally and in each division. The eight performance categories address four of the most important issues to K-12 foundations:

- Resources to enhance public education (annual revenues, revenues per student)
- Long-term financial sustainability (total assets, assets per student, investment income)
- Resources invested into programs (total grants, programs and similar amounts paid and per student – both less salaries and benefits)
- Human capital (volunteers)

Per student calculations are added to better reveal the impact a foundation is having based on the number of students in the district. "Some foundations raise large amounts of money but when compared to the number of students in their districts it becomes clear the impact on most students is minimal," Caruthers said.

Performance Categories:

- 1. Total Revenues
- 2. Revenues per Student
- 3. Total Assets
- 4. Assets per Student
- 5. Grant and Program Expenses
- 6. Grant and Program Expenses per Student
- 7. Investment Income
- 8. Volunteers

The rankings are the collective score of all eight performance categories. The foundations that appear in the most categories were ranked highest, emphasizing the importance of being well-rounded.

Data for the Stepping Up study is from the foundations 990, which is a financial report non-profits use annually to report to the U.S. Internal Revenue Service. The 2017 Stepping Up study uses the most recent 990 data available for all foundations included in this study, which is from 2015.

In addition to the national rankings, there are four revenuebased divisions, followed by a number of foundations in each division this year:

Division 1: \$2 million or more (44 foundations)

Division 2: \$1 million to \$1,999,999 (27 foundations)

Division 3: \$500,000 to \$999,999 (31 foundations)

Division 4: Less than \$500,000 (89 foundations)

This year's study uses data from foundations 990s from 2015, the most recent data available.
